ARTICLES OF INCORPORATION

The undersigned, each being of full age, do hereby set forth these Articles of Incorporation for the purposes of establishing a not-for-profit corporation pursuant to Chapter 617, Florida Statutes.

ARTICLE I - NAME

The name of the corporation is the ASAF PAC, INC.

ARTICLE II - PLACE OF BUSINESS & MAILING ADDRESS

The place of business of the ASAF PAC, INC. is 4125 Pecan Branch Road, Tallahassee, Florida 32308. The mailing address for the corporation is 4125 Pecan Branch Road, Tallahassee, Florida 32308.

ARTICLE III - PURPOSES

The purposes for which this corporation is organized is to qualify as a Committee of Continuous Existence pursuant to Section 106.04, Florida Statutes, and to accept contributions and make expenditures consistent with the powers and duties of a Committee of Continuous Existence under Florida law.

ARTICLES IV - DIRECTORS

The Board of Directors shall be selected at each annual Board meeting, by a majority vote of the Directors present at such meeting. There shall be at least five (5) members of the Board of Directors of the corporation, all of whom must be members of the corporation.
