# ARTICLES OF INCORPORATION

The undersigned, each being of full age, do hereby set forth these Articles of Incorporation for the purposes of establishing a not-for-profit corporation pursuant to Chapter 617, Florida Statutes.

#### **ARTICLE I - NAME**

The name of the corporation is the ASAF PAC, INC.

## ARTICLE II - PLACE OF BUSINESS & MAILING ADDRESS
