

ARTICLE I - NAME

The name of this corporation is: COPELAND INDUSTRIAL PARK OWNERS ASSOCIATION, INC.

ARTICLE II - ADDRESS OF PRINCIPAL OFFICE

The address of the principal office of the corporation is 2012 West University Avenue, Gainesville, Florida 32603, and the mailing address of the office of the corporation is Post Office Box 14425, Gainesville, Florida 32604.

ARTICLE III - PURPOSE OF CORPORATION

- 1. The purpose of this corporation is to provide for an owners association for the owners of the property in Alachua County, Florida, described in Exhibit A hereto.
- 2. The corporation will carry out the functions and duties of the "Association" as such are defined and set out in the Declaration of Covenants, Conditions, and Restrictions for Copeland Industrial Park as such Declaration is recorded in the public records of Alachua County, Florida, and as may be amended from time to time in accordance with the provisions thereof.

- The corporation will levy and collect adequate assessments from members of the corporation for the costs of landscaping and mowing along the roadway and for construction,
- 4. maintenance, and operation of a development sign and a common stormwater management system, if any.

ARTICLE IV - ELECTION OF DIRECTORS

The method of election of directors will be as provided in the Bylaws of the corporation.

ARTICLE V - REGISTERED AGENT AND INITIAL REGISTERED OFFICE

The registered agent and the street address of the initial registered office of this corporation in the State of Florida is:

ARTICLE VI - INITIAL DIRECTORS

The number of directors may be increased from time to time by a majority vote of the Board of Directors, but may never be less then three nor more than twelve.

ARTICLE VII - MEMBERS

Each owner of any of the property described in Article III above will automatically be a member of this corporation. Membership in this corporation will automatically terminate at such time as the member no longer owns any portion of the property described in Article III above.

ARTICLE VIII - INITIAL MEMBERS

The initial member of this corporation is the UNIVERSITY OF FLORIDA FOUNDATION, INC.

ARTICLE IX - INCORPORATOR

ARTICLE X - ASSESSMENTS

The assessments will be used for landscaping and mowing along the roadway and for construction, maintenance, and operation of a development sign and a common stormwater management system, if any.

ARTICLE XI - EXISTENCE AND DURATION

Existence of the corporation shall commence with the filing of these Articles of Incorporation with the Secretary of State, Tallahassee, Florida. The corporation shall exist in perpetuity.

<u>ARTICLE XII – AMENDMENT</u>

These Articles of Incorporation may be amended in the manner provided by law.
