**ARTICLES OF INCORPORATION
OF

ONE: The name address of this principal corporation is Sacred Touch, Inc 21296 Summer Trace Circle Boca Raton, Florida 33428, in Palm Beach County. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.

TWO: This corporation is a Nonprofit Public Benefit Corporation and is not organized for private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of, but not limited to: Child Care, Job Training Job Placement, Land Acquisition, Housing, Employment, Literacy Counseling, Temporary Shelter, Teenage Pregnancy, Substance Abuse Awareness and Prevention, Tutoring, AIDS Prevention and Awareness, Elderly Care and other programs to aid those in need.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.
