# AMENDMENT TO THE ARTICLES OF INCORPORATION OF ISLAND SOUND II AT PELICAN SOUND CONDOMINIUM ASSOCIATION, INC.

Note: Words stricken are deletions; Words underlined are additions.

The Articles of Incorporation shall be amended as follows:

#### **ARTICLE X**

Amendments to these Articles of Incorporation may be proposed and adopted as follows:

After turnover, an amendment may be proposed by either the Board of Directors or by twenty-five (25%) of the voting interests and may be considered at any meeting of the owners, regular or special, of which due notice has been given according to the By-Laws, which includes a notice of the substance of the proposed amendment; prior to turnover, by a majority of the Directors alone.

After turnover, the amendment must be approved by a vote of 67% of the voting interests who are present and voting, in person or by proxy at a duly called meeting of the members of the Corporation; prior to turnover, by the Directors alone.
