

KNOW ALL BY THESE PRESENTS: That the undersigned person, acting as incorporator of a corporation under the Florida Not For Profit Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation shall be "Florida Association of General Masters and Child Support Enforcement Hearing Officers", INC.

ARTICLE V - INITIAL REGISTERED AGENT AND STREET ADDRESS




