## ARTICLES OF INCORPORATION

OF

# INDEPENDENT LIVING FOR CHALLENGED ADULTS, INC.

#### NOT FOR PROFIT CORPORATION

# ARTICLE I

Name. The name of this corporation shall be Independent Living for Challenged Adults, Inc.

#### **ARTICLE II**

Address of Principal Office. The principal office of the corporation shall be 4764 N. Apopka-Vineland Rd., Orlando, Florida 32818.

#### ARTICLE III

<u>Purposes</u>. This corporation is a not for profit corporation. The purpose of the corporation shall be general charitable purposes, including the promotion of independent living for retarded adults.

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a

corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### ARTICLE IV

<u>Election of Directors</u>. The method of election of Directors shall be as stated in the Bylaws.

#### <u>ARTICLE VI</u>

<u>Initial Registered Office and Agent</u>. The corporation's initial registered office shall be 4764 N. Apopka-Vineland Rd., Orlando, 32818, and the name of the initial registered agent of this corporation at that address shall be: Melissa Wilson.

## ARTICLE VII

# ARTICLE VIII

Distribution of Assets Upon Dissolution. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
