The undersigned, being a natural person of the age of more than twenty-one years, does hereby act as an incorporator in adopting the following Articles of Incorporation for the purpose of organizing a Not For Profit corporation pursuant to the provisions of the Florida Business Corporation Act.

ARTICLE I: The name of the corporation ("Corporation") shall be Duval Community Services, Inc.

ARTICLE II: The principal place of business of this corporation shall be 4383 Seabreeze Dr. Jacksonville, Duval County, Florida 32250.

ARTICLE III: The purposes for which the Not For Profit corporation is organized, which shall continue to be the purposes of the Not For Profit Corporation until and if the same be amended pursuant to the provisions of the Florida Business Corporation Act, and which shall include the authority of the Not For Profit Corporation to transact any lawful business for which a corporation may be incorporated under the Florida Business Corporation Act, as are follows:

- A. To provide a range of social support services, counseling services, housing, family support, education, employment and other relevant services to persons in need of such services.
- B. To have all powers conferred upon corporations organized under the Florida Business Corporation Act.

ARTICLE IV: The manner in which the directors of the corporation shall be elected shall be contained in the By-laws of the Corporation.
