**ARTICLES OF INCORPORATION**  
**FOR**  
**DIXIE HOLLINS HIGH SCHOOL BASEBALL BOOSTERS, INC.**

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

**ARTICLE I**

The name of the corporation shall be *DIXIE HOLLINS HIGH SCHOOL BASEBALL BOOSTERS, INC.*

**ARTICLE II**

The principle place of business and the mailing address of this corporation shall be:

**ARTICLE III**

The specific purpose(s) for which the corporation is organized is (are):

To be a non-profit corporation (without capital stock), which shall be operated exclusively for educational, charitable and scientific purposes. Such educational, charitable and scientific purposes shall include carrying on activities:

- A. To encourage and maintain interest in the high school level baseball sporting program.
- B. To facilitate and lend support to the baseball program and coaching staff.
- C. To cooperate with the policies of the high school baseball program and the Board of Education.

**ARTICLE IV**

The manner in which the directors are elected or appointed is as follows:

The board of directors of the corporation shall be known as the Board of Directors. Except for

the initial Board of Directors, whose names are set forth in these Articles of Incorporation, the manner in which the Directors are to be elected or appointed will be by nomination and vote of the general membership of the corporation as provided in the by-laws of the Dixie Hollins High School Baseball Boosters, Inc.

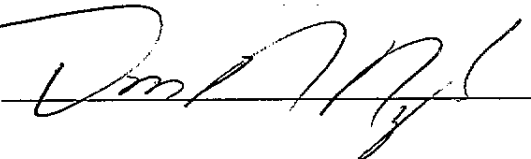
