

**Articles of Incorporation

- ONE:** The name and address of this principal corporation is Paramore Universal, Inc. 14124 NW 27 Avenue; Miami, Florida 33054, in Miami-Dade County. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.
- TWO:** This corporation is a non-profit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes to assist and bring awareness to individuals and families towards a life of self-sufficiency. The programs will consist of but shall not be limited to: Fitness, Health Awareness, Athletic Support, Educational Seminars, Cultural Activities, Information, Referrals and Assistance, Job Training, Job Placement, Land Acquisition, Employment, Counseling, and other programs to aid those in need.
- THREE:** The duration of this corporation shall be perpetual, no stock and shall have no members

  - (B) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501C (3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170 C (2) of the Internal Revenue Code.


**SIX:** The Directors are elected in accordance with the Bylaws. The name and address of the persons appointed to act as the initial Directors of this corporation are:

Any such asset not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
