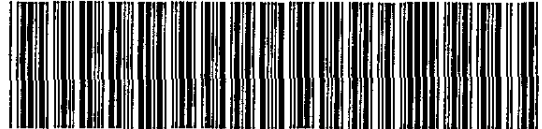

Articles of Amendment
of
North Jacksonville Family Worship Center, Inc.

These Articles of Amendment are filed pursuant to Florida Statutes Section 617.1006, to reflect an Amendment to the Articles of Incorporation of North Jacksonville Family Worship Center, Inc., and in connection therewith, the undersigned officers, acting upon authority of the Board of Directors of North Jacksonville Family Worship Center, Inc., and upon the authority of a majority of the members entitled to vote on said amendment, hereby set forth as follows:

1. The name of this Corporation is North Jacksonville Family Worship Center, Inc.
2. The Articles of Incorporation of North Jacksonville Family Worship Center, Inc. have been amended by deleting Article III in its entirety and substituting in lieu thereof the following Article III:

“Article III PURPOSES

The specific purpose for which this corporation is organized is to provide: Ministry, Church, and Bible training. This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No substantial part of the activities of this organization shall consist of carrying on propaganda, or otherwise attempting to influence legislation,

and the organization shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue law), or (b) by an organization contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue law).



The property of this corporation is irrevocably dedicated to section 501(c)(3) exempt purposes and no part of the net income or assets of this organization shall ever inure to the benefit of any private person.”

3. In accordance with Florida Statutes Section 607.1003, the referred to Amendment was adopted by the Board of Directors on the 16th day of May, 2003, and written consent to the said amendment was given on the 16th day of May, 2003 by the holders of a majority of the members entitled to vote thereon. The number of votes cast for the amendment by the members is sufficient for approval of the amendment by all voting groups of the corporation.

4. Upon the filing of these Articles of Amendment by the Department of

State, the above referred to amendment shall become effective and the Articles of
Incorporation of North Jacksonville Family Worship Center, Inc. shall be deemed to be
amended accordingly.
