ARTICLES OF INCORPORATION
OF
EGLISE BAPTISTE LASH DE' NOE, INC.
A FLORIDA NOT FOR PROFIT RELIGIOUS CORPORATION

ARTICLE I

The name of the Corporation is:

EGLISE BAPTISTE LASH DE' NOE, INC.

ARTICLE II

The address of this Corporation is:

North Miami, Florida 33161

ARTICLE III

This Corporation shall have perpetual existence unless otherwise dissolved by operation of law.

ARTICLE IV

This Corporation is organized for the purpose of teaching the Christian gospel to congregation members and the general public. This Church is non-denominational and is not presently affiliated with a denomination of Christian Churches. The New and Old Testament gospel shall be taught and prayed in the Church and to the congregation and the general public.

This Church shall be non-profit and shall rely upon donations from congregation members and the public. Emphasis shall be on the teachings of the Bible through a minister ordained by the Church of God of Revelation, originally principaled in the Republic of Haiti. This is an evangelical non-denominational Biblical Christian Church.

Exempt from taxation pursuant to Federal Law will be applied for or obtained.

The Corporation is organized for the following general purposes as well:

1. To borrow money and contract debts when necessary for the transaction of its business or for the exercise of its corporate rights, privileges or franchises or for any other lawful purpose of its incorporation; to issue bonds, promissory notes, bills of exchange, debentures and other obligations and evidence of indebtedness payable at a specified time or times or payable upon the happenings of a specified event or events, whether acquired or by mortgage, pledge, or otherwise or unsecured, for money borrowed or in payment for property purchased or acquired or any other lawful objects. However, same must be in a recognized non-profit fashion.

2. To guarantee, purchase, hold, sell, assign, transfer, mortgage, pledge or otherwise dispose of the shares of the capital stock of or any bonds, securities or evidences of indebtedness created by any other Corporation of this State or any other State or government and, while owner of such stock, to exercise all the rights, powers and privileges of ownership, including the right to vote thereon.

3. To enter into general partnerships, limited partnerships (whether the Corporation be a limited or general partner), joint ventures, syndicates, pools, associations and other arrangements for carrying on one or more of the purposes set forth herein, jointly or in common with others, so long as the Corporation would have power to do so alone. Any such ventures must be with

affiliated members of the non-denominational group or authorized by the governing officials of the venture parties.

4. To transact any and all other lawful business within the State of Florida for which Religious Non-Profit Corporations within the State of Florida are authorized, by the laws of said State and the Statutes of said State to conduct and transact.

ARTICLE V

This Corporation is authorized to issue no stock at the present time.

ARTICLE VI

Every shareholder, upon the sale for cash or kind of any new stock of this Corporation of the same kind, class or series as that which he/she already holds, shall have the right to purchase his/her prorata share thereof as nearly as may be done without issuance of fractional shares at the price at which it is offered to others prior to such offering to others.

With respect to sale of old or original stock, each shareholder, regardless of his/her ownership of stock holding, shall be entitled to purchase said Shares of Stock from the selling party prior to offer to others outside of the Corporation, provided that the party holding like stock shall have the first right of refusal and the other shareholders shall be entitled to bid on the price prior to shareholders shall be entitled to bid on the price prior to offering to the public or others outside of the Corporation.
