#### AMENDMENT OF ARTICLE

### Amendment Of Article II Purpose

The purposes for which the corporation is organized are exclusively religious, charitable and educational within the meaning of the section 501c3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United State Internal Revenue Law

#### Limit of Power

Notwithstanding any other provision of these article, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501c3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United State Internal Revenue Law

#### Dissolution

Upon the dissolution of this corporation, assets will be distributed for one or more exempt purposes " within the meaning of section 5Ol(c) (3) of the Internal Revenue Code (or corresponding section of any future federal tax code), or shall be distributed to the Federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by the Court of Common Pleas of the county in which the principal office of the corporation is then located, *exclusively* for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

In the event of dissolution, the residual assets of the organization will be turn over to one or more organizations which themselves are exempt as organizations described in sections 501c3 and 170c2 of the Internal Revenue Code of 1986 or the corresponding sections of any prior future Internal Revenue Code or to the Federal, State, or local government for exclusive public purpose.
