### Article IV Manner of Election of Directors

The Board of Directors will be appointed or elected and will consist of not less than five individuals, a majority of whom shall be other than employees/staff, and or those related by blood or marriage, which shall meet at least semi-annually to establish policy and review its accomplishments.

The Board shall appoint a functioning audit review committee, a majority of whom shall be other than employees/staff / and /or those related by blood or marriage, for the purpose of reviewing the annual audit and reporting its findings to the Board.
