

**ARTICLE ONE**

The name of the Corporation is Intervention Project for Nurses, Inc.

**ARTICLE TWO**

The address of the principal office and mailing address of the corporation is 224 North Third Street, Jacksonville Beach, Florida 32250.

**ARTICLE THREE**

The term of existence of the Corporation is perpetual and the corporate existence will commence on the filing of these articles by the Department of State.




