**ARTICLES OF INCORPORATION
OF
TREASURE COAST ASSOCIATION OF WOMEN LAWYERS, INC.**

In Compliance with Chapter 617, FLORIDA STATUTES (Not For Profit)

THE UNDERSIGNED INCORPORATOR, for the purpose of forming a not-for-profit corporation under Florida Statutes, Chapter 617, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be **TREASURE COAST ASSOCIATION OF WOMEN LAWYERS, INC.**

ARTICLE II. PRINCIPAL OFFICE
