ARTICLE I: The name of this corporation is Family Enhancement, Inc.

ARTICLE II: The registered office in the State of Florida is to be located at 5652 Nicklaus Lane in the City of Milton, County of Santa Rosa.

ARTICLE III: The nature of the business and the objects and purposes proposed to be transacted, promoted and carried on are to do any and all the things herein mentioned, as fully and to the same extent as natural persons might or could do, and in any part of the world, vis:

This is a nonstock, nonprofit corporation. The purpose of the corporation is to engage in any lawful act or activity for which nonprofit corporations may be organized under the General Corporation Law of Florida.

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), to wit:

Helping to educate teenagers and their parents to prevent pregnancy, raise self-esteem, open lines of communication, promote a drug free lifestyle and provide positive role models. The corporation will provide different types of classes for youths and parents and periodically conduct programs to give items to target groups. Examples of the items and groups include school supplies and book bags to school kids, Easter baskets to needy children, provide various lessons to children suffering low self-esteem due to abuse, and numerous other donations including food and clothing to impoverished families.

ARTICLE IV: The corporation shall not have any capital stock and the conditions of membership shall be based on simple majority vote. A Board of Directors shall manage the activities and affairs of the corporation. The number of directors which shall constitute the whole Board shall be such as from time to time shall be fixed by, or in the manner provided in, the Bylaws, but in no case shall the number be less than two. The directors need not be members of the corporation unless so required by the Bylaws of by Statute. The Board of Directors shall be elected by the members at the annual meeting of the corporation to be held on such date as the Bylaws may provide, and shall hold office until their successors are respectively elected and qualified. The Bylaws shall specify the number of directors necessary to constitute a quorum. The Board of Directors, by resolution or resolutions or in the Bylaws of the corporation, shall have and may exercise all the powers of the Board of Directors in the management of the activities and affairs of the corporation. They may further have power to authorize the seal of the corporation to be affixed to all required documents. Such committee or committees shall have such name or names as may be stated in the Bylaws of the corporation or as may be determined from time to time by resolution adopted by the board of Directors. The officers of the corporation may, if the Bylaws so provide, be classified as to term of office. The corporation may elect such officers as the Bylaws may specify, subject to the provisions of the Statute, who shall have titles and exercise such duties as the Bylaws may provide. The Board of Directors is expressly authorized to make, alter, or repeal the Bylaws of the corporation. This corporation may in its Bylaws confer powers upon its Board of Directors in addition to the foregoing, and in addition to the powers and authorities expressly conferred upon them by the Statute. This is true, provided that the Board of Directors shall not exercise authority conferred herein or by Statute upon the members. Directors and members will be elected and removed by simple majority vote of the directors as covered in the Bylaws.

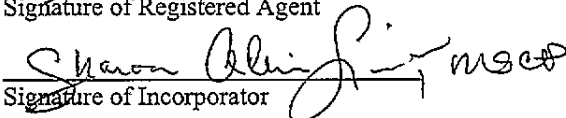
