ARTICLES OF INCORPORATION
OF

The undersigned incorporator, in order to form a not for profit corporation, in compliance with Florida Statutes, Chapter 617, adopts the following Articles of Incorporation:

ARTICLE I

Name

The Name of this Corporation shall be

C.O.P.E.S., Inc. at Lifeline.

ARTICLE II

Principal Office

The principal place of business and mailing address of this corporation shall be: 6550 Griffin Road, Suite 104, Davie, Florida 33314.

ARTICLE III

Purpose

The purposes for which this corporation is organized are:

(a) to develop an organization to teach and disseminate educational material to the public, including, but not limited to, material relating to etiology of substance abuse and addiction; substance abuse prevention; methods and choices of rehabilitation of substance abuse, through publications, lectures, seminars, small group meetings, individual behavioral evaluations and other wise.

(b) for one or more of the purposes specified in Section 501(c)(3) of the Internal Revenue Code, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code or corresponding sections of any future Federal tax code.

ARTICLE IV

Manner of Election of Directors

The manner in which the directors are elected or appointed will be specifically outlined in the corporation's by-laws.

ARTICLE V
Initial Directors/Officers

The initial directors/officers of the corporation will be elected at the initial organizational meeting of the incorporators.

ARTICLE VI
Registered Agent

ARTICLE VII
Incorporator

ARTICLE VIII
Miscellaneous Provisions

(a) The property of this corporation is irrevocably dedicated to public educational purposes and no part of the net income or assets of this corporation shall inure to the benefit of any director, officer, or any private person except that of a salaried employee of the corporation.

(b) Upon dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the Federal government, or to the State of Florida for a public purpose.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
