I called your offices yesterday and spoke with Robin and others in connection with the Administrative Dissolution of the above corporation, effective according to your web site, on or about September 21, 2001.


I explained that the corporation's president and registered agent, Robin Singer, knew nothing about this dissolution. She did not receive written notification as required by law.
