## ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following articles of incorporation

### THE CENTER FOR CHRISTIAN HEALING INC.

A Florida Not for Profit Corporation

#### ARTICLE I

The name of this corporation shall be: The Center For Christian Healing Inc.

#### ARTICLE II

The principle place of business shall be Lakeland, Florida and the mailing address shall be: 5125 Cambry Lane

Lakeland, Florida 33805

#### ARTICLE III

This corporation is formed for the purpose of engaging in any lawful activity for which corporations may be formed pursuant to Chapter 617.0202, Florida Statutes (F.S.) as a Church for the religious purposes of but, not limited to; Christian Worship, Christian Education, Evangelism and the Christian ministry of Pastoral Care and Counseling and such other lawful activities of a church and church ministries as the Board of Directors may designate from time to time. At all times the corporation activities shall be and remain in compliance with Section 501 (c)(3) of the Internal Revenue Code concerning church and charitable corporations.

#### ARTICLE IV

The manner by which directors shall be appointed is as follows: The number of directors shall be five (5) unless changed by a unanimous vote by the board. The board members shall always include the President and Vice-President, who shall be the pastor and co-pastor of the church. The other board members shall serve terms of one-year duration and shall be unanimously nominated and approved by the remaining board members to serve. Board members may serve more than one consecutive term with unanimous approval of the remaining board. Qualifications for board membership and their duties shall be as provided in the by-laws.
