

ARTICLE I The name and address of this principal corporation is S. R. Tyler Ministries, Inc., 833 South Parsons Avenue, DeLand, Fl. 32720. Volusia County. The corporation is organized pursuant to the **FLORIDA** Nonprofit Corporation Code.

ARTICLE II This corporation is a **Religious Organization / Ministry** and is not organized for the private gain of any person. The corporation is organized under the **Nonprofit Religious Benefit Corporation Law** for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consists of, but shall not be limited to: Job Training, Job Placement, Land Acquisition, Housing, Employment, Literacy, Counseling, Temporary Shelter, Teenage Pregnancy, Family Planning, Mentoring, Substance Abuse and Awareness, and AIDS Awareness programs to aid those in need.

ARTICLE III The duration of this corporation shall be perpetual, no stock and shall have no members.

ARTICLE V This corporation is organized and operated exclusively for **Religious, Charitable, and Educational** purposes within the meaning of Section 501{c}{3} of the Internal Revenue Code

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a


corporation exempt from federal income tax under the Section 501{c}(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170{c}(2) of the Internal Revenue Code.

ARTICLE VI The Board of Directors are elected in accordance with the Bylaws. The name and address of the persons appointed to act as the initial Directors of this corporation are:

ARTICLE VII On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for, **Religious, Charitable, and Educational** under Section 501{c}(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
