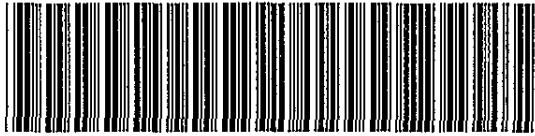

This is a letter following our phone conversation on Friday March 14, 2003. Please submit our changes in our Articles of Incorporations as follows: Article Eight with the new language as stated below,

- 1. Upon the dissolution of the corporation, its assets remaining after payment of or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a non – profit fund, foundation, or corporation, which is organized and operated exclusively for, Religious, Charitable and Education under Section 501© (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization or organization, as said Court shall determine, which are organized and operate exclusively for such purposed.**

Also amend Article Five: to change the word "Yot" to "Not"
