# ARTICLES OF INCORPORATION

## ARTICLE I

The name of this corporation shall be:

BAHAMIAN NATIONAL ASSOCIATION, INC.

# ARTICLE II

# <u>ARTICLE III</u>

The specific purpose of this corporation is to act as a catalyst for unity and economic empowerment for Bahamians, and Bahamian descendants in the United States. This corporation shall recognize and strengthen its members in matters of entrepreneurship, education, corporate communications, career development, and cultural awareness.

### ARTICLE IV

- A. This corporation is organized and operated exclusively for public purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
- B. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.
- C. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempt to influence legislation, and the corporation

shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

### ARTICLE V

The property of this corporation is irrevocably dedicated to public purposes and no part of the net income or assets of this corporation shall inure to the benefit of any director, officer, or member thereof, or to the benefit of any private person. Upon dissolution or winding up of the corporation, its assets remaining after payment, or provision or provision for payment, of all liabilities of the corporation shall be distributed to a fund, foundation or corporation which is organized and operated exclusively for public purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.

# ARTICLE VI

The business of this corporation shall be managed by the Board of Directors. The number of Directors and the manner of election of said Directors shall be as stated in the Bylaws.
