The undersigned, acting as incorporators(s) of a corporation pusuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I-The Name of the Corporation

ARTICLE VIII-Dissolution of Corporation

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purpose(s) within the meaning of Section 501 (C)(3) of the Internal Revenue Code (IRC), or the corresponding section of any future federal tax code, or shall be distributed to the federal government or to a state or local government for public purpose. Any such assets not so disposed of shall be disposed of by court of competent jurisdiction of the county in which the principle office of the corporation is then located, exclusively for such purposes or to such organization or organization(s), as said court shall determine, which is organized and operated exclusively for such purpose.

ARTICLE IX-Prohibitions

No part of the net contribution and support of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private person(s), except the corporation shall be authorized and empowered to pay reasoable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the preseding articles hereof. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 501 (C)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue Law.

ARTICLE X-Voting Power of the Board

Management of the Corporation shall be elected in accordance with the Bylaws. All corporate power shall be excersied by or under the authority of the Board of Directors, and the management of the Corporation shall be controlled by the Board of Directors. The officer of the Corporation shall consistof a Chairperson of the Board, an Executive Vice Chairperson of the Board, a President/C.E.O., who shall be entitled to vote, a Corporate Secretary, a Treasurer, an may include up to two (2) other such officers as shall from time to time designate by the Board of Directors. The President/C.E.O. may hold the position of Chairperson oif the Board of Directors simultaneously. Officers shall hold office until the date fixed in accordance with the Bylaws for the annual meeting of the Board of Directors next following the election of such officers and until their successors are elected and agree to serve.
