ARTICLES OF INCORPORATION

OF

RAYMOND R. AND MARTHA G. WERNIG FOUNDATION, INC.

The undersigned incorporator, for the purpose of forming a not for profit corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

CORPORATE NAME

The name of the not for profit corporation is Raymond R. and Martha G. Wernig Foundation, Inc. (the "Corporation").

ARTICLE II

PRINCIPAL OFFICE

The principal place of business and mailing address of the Corporation shall be 4000 Gulf Shore Boulevard North, Villa 2900, Naples, Florida 34103.

ARTICLE III

PURPOSE

The Corporation is organized for the purpose of charitable, educational, social or civic activities and to transact any lawful business for which not for profit corporations may be incorporated under the Florida Business Corporation Act.

MANNER OF ELECTION OF DIRECTORS

The Corporation shall have at least three (3) Directors, the initial Directors of which are Raymond R. Wernig, 4000 Gulf Shore Boulevard North, Villa 2900, Naples, Florida 34103, Martha G. Wernig, 4000 Gulf Shore Boulevard North, Villa 2900, Naples, Florida 34103, and R. Mark Wernig, 730 Ridgecrest Road, Akron, Ohio 44303. The number of members of the Board of Directors of the Corporation may be increased or decreased from time to time in accordance with By-Laws adopted by the Directors, but shall never be less than three (3) Directors. The initial Directors shall hold office until the first annual meeting of the corporation or until successors are elected or qualified.
