

ONE: The name of the corporation is ASSEMBLY OF TABERNACLE OF JESUS-CHRIST MINISTRIES, INC.
The address for the principal office is 750 NW 98th Street; Miami, Florida 33150.
The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.

TWO: This corporation is a CHURCH MINISTRY and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefif Corporation Law to spread the Gospel of Jesus-Christ, charitable, and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of but shall not be limited to: Preaching, ordain ministers, officers and Deacons to work for the Ministry of Christ, affordable communities, Job Training, Job Placement, Land Acquisition, Housing, Employment, Literacy, Counseling, Temporary Shelter, Teenage Pregnancy, Substance Abuse Awareness and Prevention, Tutoring AIDS, Elderly Care and other programs to aid those in need.

THREE: The duration of this corporation shall be perpetual, and shall have no stock.
