ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF GET FLANAGAN A STADIUM, INC.

Pursuant to the provisions of § 617.1006, Florida Statutes, Get Flanagan A Stadium, Inc., a Florida Non-Profit Corporation, adopts the following amendments to its Articles of Incorporation:

FIRST: The name of the corporation is Get Flanagan a Stadium, Inc.

SECOND: The following amendments to the Articles of Incorporation of Get Flanagan A Stadium, Inc. were adopted by the corporation:

Article I is being amended to rename the corporation to Falcon Foundation, Inc.

Article III is being amended to delete Article III in its entirety and replace it with the following:

The purpose for which the corporation is organized is to maintain a multi-purpose stadium at Charles W. Flanagan High School, Pembroke Pines, Florida; and for the general support of Charles W. Flanagan High School, Pembroke Pines, Florida.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempt to influence legislation, except as provided in section 501(h) of Title 26, the Internal Revenue Code of 2004, and the organization shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of or in opposition to any candidate for public office, except as provided in section 501 (h) of Title 26, the Internal Revenue Code of 2004.

Notwithstanding any other provision of this Article, the corporation shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal income tax under section 501 (c) (3) of Title 26, the Internal Revenue Code of 2004 (or the corresponding provision of any future United States Internal Revenue law), or (b) by an organization contributions to which are deductible under section 170(c)(2) of Title 26, the Internal Revenue
