


ONE: The name and address of this principal corporation is CRUSADE HELPING HANDS NEIGHBORHOOD OUTREACH MINISTRIES INC. 3620 NW 197th Avenue Opa Locka, FL. 33055 The Corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.

TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law, for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of but shall not be limited to: Seminars, Outreach Advocacy Programs for the Homeless and Disadvantaged, Health Care, Housing, Employment, Literacy, Counseling, Temporary Shelter, Teenage Pregnancy, Job Training, Job Placement, and Acquisition. Substance Abuse Awareness and Prevention, Tutoring, AIDS Awareness, Elderly Care, Mentor ship, Providing Clothing, food and other programs to aid those in need.

THREE: The duration of this corporation shall be perpetual, with no stock and shall have no members.
