We, the undersigned, being desirous of forming a Corporation Not For Profit, for charitable, philanthropic, and educational purposes, under the provisions of and In Compliance With Chapter 617 of the Florida Statutes, (Not for Profit), do agree to the following:

ARTICLE I - NAME

The name of the Corporation shall be: The Florida Indian Center, Inc.

ARTICLE II - PRINCIPAL OFFICE

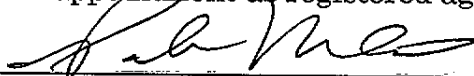
