WE, THE UNDERSIGNED, hereby certify that we have associated ourselves together for the purpose of establishing a corporation under and in accordance with the provision of Chapter 617 Florida Statutes, providing for the information, rights and privileges and immunities of the corporation not for profit and in pursuance of the terms of said Statutes, we hereby declare and certify as follows:

ARTICLE I. NAME


ARTICLE IX. BY-LAWS
