

ARTICLES OF
PRAISE OF ALL NATIONS MINISTRIES, INC.

ARTICLE I

The name of this religious organization shall be:

Praise Of All Nations Ministries, Inc.

ARTICLE II

The principle place of business and mailing address of the corporation shall be:

**8121 Puffin Drive
Orlando, Florida 32825**

ARTICLE III

The specific purpose(s) for which the corporation is organized is(are):

- (a) The general purpose of this corporation shall be to propagate the Gospel of Jesus Christ, and to build and maintain Churches, Missions, Schools, and other institutions of a religious, charitable, or educational nature. Its plan of operation shall be to have an association of members in a Christian organization under the direction of the Presiding Pastor and the Board of Trustees, such organization being entirely independent, without affiliation with any church denomination.
- (b) The Board of Trustees shall have sole power to amend these Articles of Incorporation from time to time. Member's views and opinions will be considered as to feasibility and merit for the betterment and advancement of the Church and acted upon accordingly.
- (c) No part of the net earnings of the corporation shall insure to the benefit of, or be distributable to its Members, Trustees, Officers, or other private persons, except that corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in Paragraph (f) hereof.

- (d) No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political candidate for public office, notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (A) by a corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (B) by a corporation, contributions to which are deductible under Sections a70 (c) (2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).
- (e) This corporation does not afford pecuniary gain, incidentally or otherwise, to its members.
- (f) Upon the dissolution of the corporation, the Board of Trustees shall, after paying or making provisions for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purpose of the corporation in such manner, or to such organization organized and operated exclusively for charitable, educational, religious, literary or scientific purposes as shall at the time qualify as an example organization or organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954, or the corresponding provision of any future United States Internal Revenue Law, as the Board of Trustees shall determine. Any such assets not so disposed of shall be disposed of by the district court of the County in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
- (g) The name of the Church body within this corporation shall be Praise Of All Nations Church.

ARTICLE IV

Founding Directors are appointed or elected as stated in the ^{by-laws} ~~by-laws~~ Founding Directors shall appoint succeeding directors to fill all positions required by this corporation.




