The undersigned, acting as incorporator of a not for profit corporation under the Florida Not For Profit Corporation Act, in compliance with Chapter 617, of the Florida Statutes adopts the following Articles of Incorporation for such corporation:

**ARTICLE I:** The name of the corporation is:

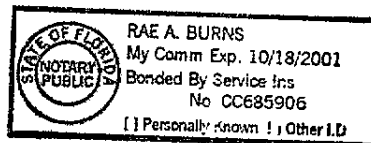
