ARTICLE I. - NAME

Section 1. The name of this Organization shall be:

ARTICLE II. - ADDRESS

ARTICLE III. - OBJECT

Section 1. This object and purpose of this organization are

continuation and advancement of the public library
in West Orange County, FL.

shall be nonpartisan, non-sectarian, non-sectional,
and shall take no part in, or lend its support to
the election or appointment of any candidate for
public office.

ARTICLE V. - BOARD OF DIRECTORS

Section 1. The number and method of election of directors shall be stated in the bylaws.
