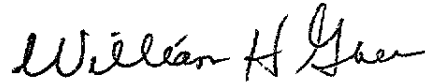

OF

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is God Is The Answer Ministry, Inc.

ARTICLE II - DURATION

The corporation shall exist perpetually.

ARTICLE III - PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office of the corporation shall be 387 East Burdick Avenue, DeFuniak Springs, Florida 32433, and the mailing address of the corporation shall be 387 East Burdick Avenue, DeFuniak Springs, Florida 32433.

ARTICLE IV - PURPOSE OF THE CORPORATION

The purpose of the corporation is to be an agency of God for evangelizing the world - reaching the lost with the gospel of Christ; to be a corporate body in which men may worship God - ministering to the Lord; and to be a channel of God's purpose to build a body of saints being perfected in the image of Christ - helping believers attain Christian maturity.

ARTICLE V - MEMBERSHIP

The qualifications for members and the manner of their admission shall be regulated by the By-Laws.

ARTICLE VI - INITIAL REGISTERED OFFICE AND REGISTERED AGENT
