ARTICLES OF INCORPORATION
OF
UNITY IN DIVERSITY FOUNDATION, INC.

The undersigned incorporators hereby make, subscribe to, acknowledge and file these Articles of Incorporation for the purpose of organizing and incorporating a corporation not-for-profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be:

UNITY IN DIVERSITY FOUNDATION, INC.

and shall hereinafter be referred to as the "corporation". The street address of the initial principal office and the mailing address of the corporation is 880 Riverside Drive, Ormond Beach, Florida 32176.

ARTICLE II

The corporation shall become effective upon the filing of these Articles with the Florida Department of State and the corporation shall have a continuous and perpetual existence thereafter.

ARTICLE III

The general purpose for which the corporation is initially organized are those matters set forth in Section 617.0301, Florida Statutes, and specifically to foster unity, appreciation and friendship between Americans and all peoples of differing nationalities and cultures through the use of education and open exchange of ideas, philosophies, histories, arts and literature. It is further intended that the corporation qualify and register under Section 501(c)(3), Internal Revenue Code of 1986, as amended.

ARTICLE IV

The directors of the corporation shall be elected as provided in the Bylaws of the corporation.

ARTICLE V

There are no provisions in these Articles or in the Bylaws of the corporation which limit in any manner the corporate powers authorized under Chapter 617, Florida Statutes.

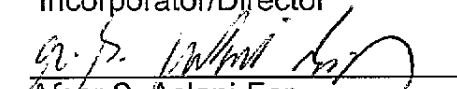
