**ARTICLES OF INCORPORATION OF
GREATER BETHLEHEM BAPTIST CHURCH, INC., a Non Profit Corporation**

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be GREATER BETHLEHEM BAPTIST CHURCH, INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and mailing address of the corporation shall be: 333 South Clara Avenue, DeLand, Florida 32720.

ARTICLE III - PURPOSE

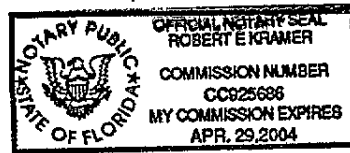
