## ARTICLES OF INCORPORATION **OF**

## A FLORIDA NONPROFIT CORPORATION

Article 1. Name

The name of the Corporation shall be: Divine Creations?

Article 2. Principal Office

<u>Article 3.</u> Duration The Duration of the Corporation is perpetual.

Article 4. **Purposes** 

The purposes of the Corporation are as follows:

- This Corporation is not-for-profit corporation organized under Chapter 617, <u>A.</u> Florida Statues. It is not organized for the private gain of any person. The specific purposes of this Corporation are: To provide educational, cultural, recreational, social, & job training skills to benefit minors in the age range of 14 - 17 years of age who are economically disadvantaged. To provide drug awareness education.
- To exercise all rights and powers conferred by the laws of the State of Florida <u>B</u>. upon nonprofit Corporations.
- <u>C</u>. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the IRS Code and not part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of it's stated purposes.

Article 5. Members The Corporation shall have Voting members, who shall be selected and may be removed by the Voting members, and shall have all the rights and privileges of members of the Corporation.
