

ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF

"Stramosa Homeowners Association, Inc

FIRST: Amendment adopted:

Document no. N00000004082

Article no. III (AMENDED)

1. Said (Stramosa Homeowners Association, Inc) is organized exclusively for charitable, educational, religious, handicapped, or scientific purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding section of any future Federal tax code).

2. No part of the net earnings of the Stramosa Homeowners Association, Inc (corporation / association / trust) shall inure to the benefit of, or be distributable to, its members, trustees, directors, officers, or other private persons, except that the Stramosa Homeowners Association, Inc (corporation / association / trust) shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of section 501(c)(3) purposes. No substantial part of the activities of the Stramosa Homeowners Association, Inc (corporation / association / trust) shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the Stramosa Homeowners Association, Inc (corporation / association / trust) shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

3. Notwithstanding any other provision of these articles, the Stramosa Homeowners Association, Inc (corporation / association / trust) shall not carry on any other activities not permitted to be carried on by a (corporation / association / trust) exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding section of any future Federal tax code).

4. Upon dissolution of this Stramosa Homeowners Association, Inc (corporation / association / trust), assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding section of any future Federal tax code) or shall be distributed to the Federal, State, or Local Government for a public purpose.

Done and completed on this 1st day of August, 2000.
