**AMENDED CORPORATION DOCUMENTS**  
**ARTICLE OF CORPORATION/ORGANIZATION BYLAWS DATED JUNE 21, 2000**

**ARTICLE X**

(X) Said corporation/organization is organized exclusively for charitable, religious, educational and scientific purposes, including for such purpose, the making of distribution to organization under section 501(c)(3) of the Internal Revenue Code ( or the corresponding section of any future Federal Tax code).

(x) No part of the earnings of the corporation/organization shall inure to the benefit of, or be distributed to its members, trustees, directors, officers, or other private persons, except that the corporation/organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of section 501(c)(3) purposes. No substantial part of the activities of the corporation/organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation/organization shall not participate in, or intervene in ( including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

(x) Upon dissolution of this corporation/organization assets shall be distributed for one or more ~~exempt~~ purposes within the meaning of section 501 ( C ) (3) of the Internal Revenue Code, or corresponding section of the Internal Federal Tax code, or shall be distributed to the Federal government or to a state or local government for public purpose.
