The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Act, hereby adopts the following Articles of Incorporation:

The name of this Corporation shall be TEEN ANGLERS, INC.

The principal place of business and mailing address of this Corporation shall be 701 Marllo Road, Kissimmee, Florida, 34744.

ARTICLE III

The specific purposes for which the Corporation is organized are:

To encourage and to provide the framework, structure, assistance and personnel for the establishment and maintainance of a program of Sport Fishing for teen agers in high schools. The goals are to teach students how to fish, sportsmanship and ethics of fishing and boating, respect for the environment, boating knowledge and safety and provide practical experience by active participation in fishing and fishing competition.

ARTICLE IV

The manner in which the members and the directors are appointed is:

The members of the Corporation shall also constitute the Board of Directors and shall be persons who embrace the goals and purposes of the Corporation and exhibit a willingness to participate in its programs. The original members and Board of Directors shall be appointed by the Incorporator. Additional and replacement members shall be appointed by a majority vote of those present at any Board of Directors meeting.

ARTICLE VII

The purposes for which TEEN ANGLERS, INC. is organized are exclusively charitable, scientific, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior to future law, or to Federal, State, or Local Government for exclusive public purpose.
