Pursuant to the provisions of section 617.1006, Florida Statues, this Florida Not For Profit Corporation adopts the following amendments to its Articles of Incorporation:

#### Amendment 1

Article IX, Section 2, Liquidation, is amended to read as follows:

Upon dissolution of the corporation, the Board of Directors shall pay or make provision for the payment of all liabilities of the corporation, and shall thereafter dispose of all the assets of the corporation to such organization or organizations organized exclusively for charitable, educational, religious, literary, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3), Internal Revenue Code (or the corresponding provision of any future United States Internal Revenue law), as the Board of Directors shall determine.
