ARTICLE 1. NAME: The name of the Corporation is Jolo^R Enterprises Inc.

ARTICLE 3. The purpose of the Corporation is as follows:

A. This Corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purpose of the Corporation are as follows:

1. To develop and implement programs for the socioeconomic advancement of low income communities with maximum control and participation by residents of such communities, and focusing in the areas of education, economic enterprises, and values.
2. To develop programs and/or support existing programs addressing the issues of juvenile delinquency, crime prevention, rehabilitation of law violators; rehabilitation of alcohol and drug abusers; the elimination of prejudice and discrimination; affordable housing for low-moderate income families; supplying money, goods or services to the poor.
3. To provide goods and services for the primary and mutual benefit of it's members and patrons as ultimate consumers, and to the end to operate facilities for their production, purchase and distribution; to associate with other cooperatives; to promote the cause of cooperation and disseminate information about the philosophy of consumer cooperation and cooperative history, principles, methods and progress.

4. To exercise all rights and powers conferred by the laws of the state of Florida upon nonprofit corporations.

B. Notwithstanding any other provision of the Articles, the purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501 (c) 3 of the Internal Revenue Code of 1986 or the corresponding provisions of any future U.S. Revenue Law.

C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporation under the Internal Revenue Code and no part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, or officers ; but the corporation shall be authorized and empowered to pay reasonable compensation to those people for services rendered, and to make payments and distributions in furtherance of its state purposes.

ARTICLE 4. Members: The Corporation shall have voting members , who shall be elected (and may be removed) by the voting members, and who shall have all the rights and privileges of members of the Corporation. The bylaws may provide for nonvoting members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the bylaws, but who shall not have the right to vote. 
