

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

HEALTHPARK FLORIDA EAST PROPERTY OWNERS ASSOCIATION, INC.

Pursuant to the provisions of Section 617.1006. Florida Statutes, this Florida Not-For-Profit Corporation adopts the following amendment(s) to its Articles of Incorporation (otherwise, all other provisions shall remain the same):

Amendment Adopted:

Language to be added is underlined. Language to be deleted is struck through.

ARTICLE X

The Association shall have two classes of voting members as follows:

Class A: – Class A members shall be all Lot owners, with the exception of Declarant, Each Lot owner shall be entitled to east a vote either in person or by proxy, in accordance with the percentage vote appurtenant to such Lot, at all special or annual meetings of Lot owners. The number of votes for each Lot shall be determined by allocating one (1) vote for each .001 (rounded off to the nearest thousandth) of common interest attributable to said Lot, based on a fractional formula wherein the numerator is the total number of square feet contained in the Lot and the denominator is the total number of square feet contained in the aggregate of all Lots lying within the Property. The total votes assigned to each Lot at HealthPark Florida East are identified on Exhibit "C" attached to the By-Laws of HealthPark East Property Owners Association, Inc. If any Lot shall be subdivided, (which shall be done only with Declarant's prior written approval), each subdivided Lot shall be entitled to vote on the same basis, applying the same numerical formula. When more than one person or entity holds an interest in any particular Lot, all such persons or entities shall be members of the Association and the vote for such Lot shall be exercised by one (1) representative as they may determine among themselves. However, where a Member Association has been established, voting for the Owners subject to the jurisdiction of that Member Association shall be through that Member Association. Upon creation of a Member Association, the participating and voting Member of the Master Association shall be that Member Association created. If any Member Association is voluntarily dissolved (except incident to a merger with the Master Association), that Member Association's rights to membership shall be transferred to another corporation, or to a trustee, which shall have and exercise such Member Association's membership rights, obligations, and privileges as long as the Master Association exists. The Members shall exercise their voting rights, when a vote for Members is required, through a representative appointed by the Board of Directors of their respective Member Associations.
