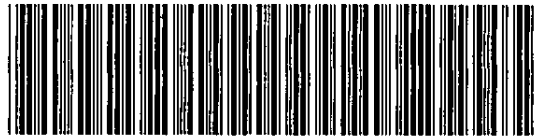

RESOLVED

Pursuant to the Florida Not For Profit Corporation Act, particularly Section 617.1402 & 617.1403, F.S., the undersigned governing body of the Capital Projects Finance Authority, as the sole member of the corporation, hereby dissolves CAPFA CAPITAL CORP. 2000A, a corporation not for profit formed under the laws of the State of Florida.

ARTICLE I

NAME

ARTICLE II

SOLE MEMBER

The sole member of the corporation is the governing body of the Capital Projects Finance Authority.


ARTICLE VII
