ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

ARTICLE III PURPOSE

The purpose for which this corporation is organized is educational within the meaning of Section 501(c)(3) of the Internal Revenue Code, as now enacted or hereafter amended, including for such purposes, the making of distributions to organizations that also qualify as Section 501(c)(3) exempt organizations.
