- ONE: The name and address of this principal corporation is Althena Dennard's Family Day Care, Inc. located at 8073 Wakefield Ave. Jacksonville, Florida 32208, in Duval County. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.
- TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for, charitable and educational purposes to aid the poor and disadvantaged individuals and families toward a life of self-sufficiency. The programs will consist of but shall not be limited to: Child Care, Emergency Temporary Housing, Job placement, Land Acquisition, Employment, Literacy, Counseling, Teenage Pregnancy, Substance Abuse Awareness and Prevention, Tutoring, Summer Camp, AIDS, Elderly Care, Community Employment, Computer Labs, Drama/Arts, and other programs to aid those in need.
- THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.

- (a) This corporation is organized and operated exclusively for Educational and Charitable purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code.

- (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.
