
ONE: The name and address of this principal corporation is Ms. Dee's Child Care, Inc. located at 1198 West 10th Street Jacksonville, Florida 32209, in Duval County. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.

TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for, charitable and educational purposes to aid the poor and disadvantaged individuals and families toward a life of self-sufficiency. The programs will consist of but shall not be limited to: Twenty four hour Child Care, Music, Spanish Lab, Teen Job Placement Land Acquisition, Sign Language, Counseling, Teen Parent Classes, Tutoring, Summer Camp, Before & After School Care, Community Employment, Computer Labs, Seminars, Drama & Arts, Health Fairs, a yearly Community Bash, and other programs to aid those in need.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.

- (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.

SIX: The Directors are elected in accordance with the Bylaws. The name and address of the persons appointed to act as the initial Directors of this corporation are:



Any such asset not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such organized and operated exclusively for such purposes.
