TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for, charitable and educational purposes to aid the poor and disadvantaged individuals and families toward a life of self-sufficiency. The programs will consist of but shall not be limited to: Child Care, Emergency Temporary Housing, Job placement, Land Acquisition, Employment, Literacy, Counseling, Teenage Pregnancy, Substance Abuse Awareness and Prevention, Tutoring, Summer Camp, AIDS, Elderly Care, Community Employment, Computer Labs, Drama/Arts, and other programs to aid those in need.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.


