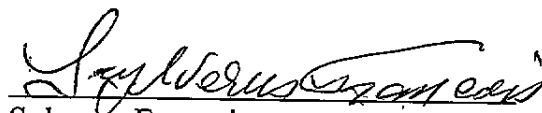

ONE: The Name and address of this principal corporation Eben-Ezer Community Center, Inc., 312 NW 7th Street, Fort Lauderdale, Florida 33311. The corporation is organized pursuant to FLORIDA Nonprofit Corporation Code.

TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and education purposes to aid individuals and families towards a life of self-sufficiency. The programs will consist of, but shall not be limited: Youth Education Development, Counseling, Early Childhood Development, Tutorial Program, Computer Literacy, Study Center, Youth and Senior Community Enrichment, Youth at High Risk.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.

FIVE:

(a) This corporation is organized and operated exclusively for Educational and Charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

(b) Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code.

SEVEN:

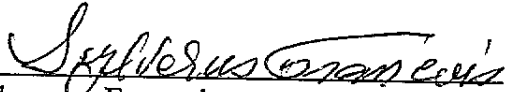
