**ARTICLES OF INCORPORATION**

In Compliance with Chapter 617, F.S., Not for Profit)

**ARTICLE I                      NAME**

The name of the corporation shall be: Iglesia Bautista Hispana de Daytona, Inc., hereafter referred as the Church.

**ARTICLE II                      PRINCIPAL OFFICE**

**ARTICLE III                      PURPOSE**

The purpose for which the corporation is organized is: To maintain and conduct services to worship God, preaching and teaching the Gospel of Jesus Christ and in general promote the interests of the Kingdom of God in accordance with the Doctrine of Jesus Christ.

**ARTICLE IV                      MANNER OF ELECTION**

The manner in which the directors are elected or appointed: The business of the Church shall be governed and managed by officials elected from the Church's membership by the members of the Church in a meeting that shall be held within the first fifteen (15) days of the month of March each year. The        /        <sup>directors</sup> shall be elected by vote with the approval of a half plus one of the members of the Church. Therefore the        /        <sup>directors</sup> shall serve a one-year term, as long as they maintain their memberships active.

The        /        <sup>directors</sup> of the Church may be re-elected according with the manner of election described above. The Board of Directors may be increased or decreased, and they will represent the Church in all legal matters.

**Paragraph:** The Pastor/President is not subjected to election by the manner described above. (I Timothy 3:1-7) The Pastor/President is a permanent position unless the Church's membership decides unanimously to substitute him/her. In the event the Pastor/President resigns or has to be substituted, the leadership of the Church shall be the responsibility of the Pastor/President of the Board and two (2) deacons, which shall be in charge of searching for and naming a new pastor, this triumvirate will be able to discreetly ask advise from the Florida Baptist Convention, Hispanic Ministries. The pastor shall be ex-officious member of all designated committees, commissions, etc., will preside over business meetings, will lead Church services and will minister the Word of God. The Pastor is the spiritual leader of the Church and no member should seek the spiritual help of other pastors without the knowledge of the one who according to the will of God, through His Holy Spirit and the Church, occupies that position (I Thessalonians 5:12-13).

**ARTICLE VIII COMPETENCY**

Upon incorporating the Church will be able to sue and be sued. Will be able to buy Real Estate and private properties. All business will have to be transacted under its Constitution. The Church will not be able to conduct business outside the law, nor have any activity or practice that is prohibited to such an organization, except what is related to the federal taxes under the Internal Revenue Code. The Church will not distribute dividends, or benefits, or earnings to members, directors, officials or other private individuals, except payments authorized to compensate for some service received and make payment and distributions in relation with that purpose.

The Church's Constitution may be modified in any of its forms, by a majority vote of the members.

The articles of this Constitution may be approved by two-third (2/3) votes of the members present in a voting session.

**ARTICLE IX ASSOCIATIONS**

The Church will maintain its autonomy thus it will recognize other Christian denominations having a sound doctrine. This Church is spiritually and morally associated with the Florida Baptist Convention - FBC.

**ARTICLE IX THE MEMBERS**

The prerequisites for joining this Church shall be: To have accepted our Lord Jesus Christ as personal Savior, be baptized by immersion, accept the covenant of the Baptist Church, give testimony as a faithful and consistent Christian, fulfill the doctrine, the covenant, and the Rules of the Church.

A qualified person can be admitted as member by letter of recommendation from another church. Acceptance will be after the Pastor and officials have examined the references. A person can be admitted as member as a result of his/her testimony and baptism.

**ARTICLE X THE OFFICIALS**

*Deacons:* (Acts 6:1-7; I Timothy 3:8-13) Shall be elected or reelected at the annual meeting.

Prerequisites and Duties:

- A) A Good Testimony (Acts 6:1-7)
- B) Upright in his/her attitudes, serve loyally and constantly cooperate with the pastor. Sample: Joshua with Moses).
- C) Help the Pastor to minister the Lord's Supper and make preparations for Baptisms.
- D) Will be in charge of collecting the offerings during the services.

*Secretary:* Will maintain permanent records of all of the Church's transactions. Shall be elected by the Church at the annual meeting. May be reelected.

*Treasurer:* Will receive the offering money. Will make payments of amounts established in the Church's budget and/or approved by it. Payments shall be made by official check. Checks, that is to say all payments. Shall be disbursed after being reviewed and signed by the Pastor. The Pastor/President and the Treasurer shall sign all checks issued by the Church. There shall be an additional alternate signature, which shall be required in the event that the Pastor/President is not available; that signature shall be that of the Secretary.

When for any unforeseen reason it is required to bypass the normal process in making a payment, the following conditions shall be taken into consideration:

- A) Under no circumstances will the emergency fluid or crisis relief fluid, be given to any one person or family. The Pastor/President, the Treasurer and the Secretary will establish the amount of the assistance according to each individual case.
- B) The individual or family receiving the help shall be introduced to the Pastor, who will award the agreed

upon amount.

- C) A counseling and orientation program will be established for the individual/family receiving assistance, and a report will be made to the Pastor at all times.

*Other Church Officials:* Director of Christian Education, Superintendent of Sunday School, Evangelism, Stewardship, Missions, Leaders of different auxiliary groups. Will be elected or appointed to their positions at the Church's annual meeting.

*Commissions:* Audit Commission: Will comprise of the Pastor/President and two (2) members who shall be appointed by the Board of Directors. At the Pastor's discretion and/or the Board of Directors, other commissions will be appointed, according to necessity and the legitimacy of the corresponding function

**ARTICLE XI MEETINGS**

The meetings shall be held: Sundays: Sunday School classes, which will the responsibility of the Department of Christian Education, in accordance with the programming which has been agreed upon by the Pastor.

Praise and Worship Service: During the week: Tuesdays, Wednesdays and Saturdays.

There will be a quarterly business meeting, the last Saturday in March, June, September and December. Annual meetings will be held in accordance with the calendar of the Association to which this Church is affiliated.

The Pastor may call business meetings or any other type of meetings when necessary. Fifty percent plus 1 of the Church's members will establish the quorum for meetings. The Lord's Supper will be celebrated the first Sunday of each month.

The fiscal year will be from January 1st to December 31~ of each year.

**ARTICLE XII DISSOLUTION**

In case of dissolution, if there is no agreement, properties, furniture, documents and other valuables will become the property of the Florida Baptist Convention - FBC.
